- RFP for "Selection of an agency for hiring of vehicles in Bihar Vikas Mission, Patna" was published vide NIT Ref. No.: BVM/2024-25/Proc/Vehicle/04 dated 20-Jul-2024
- A total of 10 bids were received in response to the tender.
- As per schedule, **Bid Opening meeting was held at 10:30 AM on 16-Aug-2024** at Bihar Vikas Mission Office, Rajvanshi Nagar, Patna under chairmanship of Chief General Manager, Bihar Vikas Mission.
- Representatives of 5 agencies attended the bid opening meeting, namely (i) Pratibha Tour & Travels, (ii) Gungun Enterprises, (iii) Bharti Tour and Travels (iv) Sajjan Tour and Travels (v) Khushi Travels and Communication were present in the meeting.
- First the technical bids were opened in presence of the members of Tender Evaluation Committee and representative of the bidders. Evaluation of the technical bids was carried out subsequently.
- **A total of 5 bidders were found qualified** in the Technical Evaluation, namely (i) Rameshvaram Engitech Pvt. Ltd., (ii) Nisha Tour & Travels, (iii) Bharti Tour and Travels, (iv) Sajjan Tour and Travels, and (v) Om Surya Enterprises.
- **A total of 5 bidders were found disqualified** in the Technical Evaluation, namely (i) Birla Travels (Parsa Bajar) (ii) Pratibha Tour & Travels, (iii) Khushi Travels and Communication, (iv) Gungun Enterprises and (v) Birla Travels (West Patel Nagar).
- Reasons of disqualification of bidders were sent individually to the respective bidders via e-mail dated 16.08.2024 with an opportunity to submit their representation regarding any objection / grievances within 2 days.
- The meeting concluded with a note of thanks to all participants.
