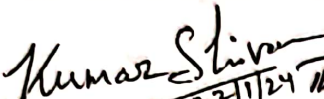

- RFP for "Selection of an Agency for Printing of Books for Bihar Vikas Mission", was published vide NIT Ref. No. BVM/2023-24/Proc/06 dated 02-01-2024.
- A total of 3 bids were received in response to the RFP.
- As per schedule, bid opening meeting was held at 11:00 AM on 16-01-2024 at Bihar Vikas Mission Office, Rajvanshi Nagar, Patna under chairmanship of Chief General Manager, Bihar Vikas Mission.
- The technical bids were opened in presence of the members of Tender Evaluation Committee and representative of the bidders. Evaluation of the technical bids was carried out subsequently.
- Bids submitted by 2 bidders were found qualified in the Technical Evaluation. The bidders qualified in the technical evaluation are - (i) Vivid Offset and (ii) Patna Offset Press.
- Bid submitted by Patliputra Printech was rejected in the technical evaluation. Reasons of rejection were sent individually via e-mail to the bidder disqualified in the Technical Evaluation with an opportunity to submit their objections/grievances, if any, within 2 days from publication of the proceeding.
- Meeting for decision on representation received from bidder disqualified in Technical Evaluation and Opening of Financial Bids was held at 11:00 AM on 22-01-2024 as scheduled vide BVM letter no. 26 dated 19-01-2024.
- No objection/grievance was received from M/s Patliputra Printech whose bid was rejected in the technical qualification, therefore it was unanimously decided to reject their bid and financial quotation submitted by them was not considered for evaluation.
- Financial bid submitted by the two bidders qualified in technical evaluation was opened for evaluation in the meeting held on 22-01-2024.
- The rate quoted by the bidders in their financial bid are as follows:

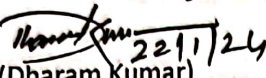

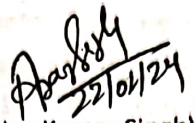
- M/s Patna Offset Press was selected as L1 agency for printing of books.

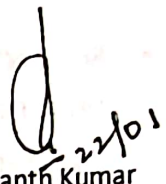

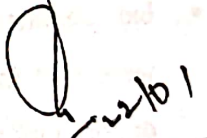
