- As per schedule, bid opening meeting was held at 11:00 AM on 07-11-2023 at Bihar Vikas Mission Office, Rajvanshi Nagar, Patna under chairmanship of Chief General Manager, Bihar Vikas Mission.
- The technical bids were opened in presence of the members of Tender Evaluation Committee and representative of the bidders. Evaluation of the technical bids was carried out subsequently.
- Bids submitted by 10 bidders were found qualified in the Technical Evaluation. The bidders qualified in the technical evaluation are - (i) ANIMATION SECURITY SERVICES PVT. LTD., (ii) Commando Industril security Force, (iii) Ex-bureau, (iv) Expert Services Consultancy, Patna, (v) (ISS) Imperishable Security Service Pvt. Ltd., (vi) LORD KRISHNA SECURITY & SERVICES Pvt. Ltd., (vii) MAA VANDEVI SECURITY & INFRASTRUCTURE PVT. LTD, (viii) Preeminence Security Services Pvt. Ltd., (ix) SIMANCHAL DETECTIVE & SECURITY SERVICES PVT. LTD. and (x) Smart Tracker Services Pvt. Ltd.
- Bids submitted by 3 bidders were rejected in the Technical Evaluation. The bidders disqualified in the technical evaluation are - (i) BISHWAS UNISERVICES PRIVATE LIMITED, (ii) Roushan Enterprises and (iii) UJJWAL ENTERPRISES. Reasons of rejection will also be sent individually via e-mail to the bidders disqualified in the Technical Evaluation.
- Rejected bidders may submit their objections/grievances, if any, within 2 days from publication of the proceeding beyond which no request shall be considered and it will be assumed that you do not have any objection. All grievances received will be put before Tender Evaluation Committee for consideration. No new documents shall be accepted from any of the bidders.
