- RFP for “Empanelment of AMC service provider agency and selection of an agency for providing comprehensive Annual Maintenance Services (AMC) for various equipments (including computers / printers / server and peripherals) installed at BVM offices located in Patna”, was published vide NIT Ref. No. BVM/2023-24/Proc/07 dated 12-01-2024.
- A total of 5 bids were received in response to the RFP.
- As per schedule, bid opening meeting was held at 11:00 AM on 09-02-2024 at Bihar Vikas Mission Office, Rajvanshi Nagar, Patna under chairmanship of Chief General Manager, Bihar Vikas Mission.
- The technical bids were opened in presence of the members of Tender Evaluation Committee and representative of the bidders. Evaluation of the technical bids was carried out subsequently.
- Bids submitted by 2 bidders were found qualified in the Technical Evaluation. The bidders qualified in the technical evaluation are - (i) Quantum Technologies and (ii) Shiva Construction & Supply.
- Bids submitted by 3 bidders were found defective in the Technical Evaluation and were therefore rejected. The bidders are - (i) Nirmal Pravidya Infotech (P) Ltd. (ii) Devi Construction and (iii) Rapidtech IT services Private Ltd. Reasons for rejection are as follows:
 - i. Nirmal Pravidya Infotech (P) Ltd. – Non-submission of Earnest money Deposit (or proof of registration with Central Purchase Organisation / State Purchase Organisation, National Small Industries Corporation (NSIC) or the concerned Department for exemption from submission of EMD.)
 - ii. Devi Construction – Non-submission of the following - Tender Document Fee, Earnest money Deposit, PAN Card, Latest GST return, Declaration of not blacklisted / debarred by any government organisation and no criminal conviction / case pending in any Court of Law, Minimum Annual Turnover of Rs 5 lakhs (Rupees Five Lakhs) for last three declared financial years, Income tax return for last 3 assessment year i.e. AY 21-22, AY 22-23 and AY 23-24, Experience in providing AMC services for similar items for a minimum 2 years and Acceptance of terms and conditions by bidder.
 - iii. Rapidtech IT services Private Ltd. – Non Non-submission of the following - Tender Document Fee, Earnest money Deposit (or proof of registration with Central Purchase Organisation / State Purchase Organisation, National Small Industries Corporation (NSIC) or the concerned Department for exemption from submission of EMD.), Declaration of not blacklisted / debarred by any government organisation and no criminal conviction / case pending in any Court of Law and Income Tax return for AY 22-23.
- Reasons of rejection are also sent individually via e-mail to the bidders disqualified in the Technical Evaluation.
- Rejected bidders may submit their objections/grievances, if any, within 2 days from publication of the proceeding beyond which no request shall be considered and it will be assumed that they

do not have any objection. All grievances received will be put before Tender Evaluation Committee for consideration. No new documents shall be accepted from any of the bidders.
