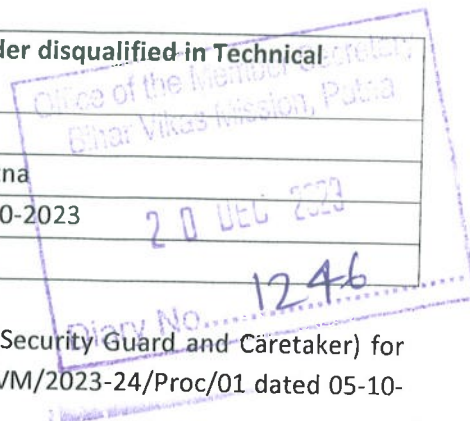


**Proceeding of the meeting for decision on representation received from bidder disqualified in Technical Evaluation and Opening of Financial Bids received for
"Selection of an Agency for providing Security Services (Security Guard and Caretaker) for BVM offices located in Patna"**

- RFP for "Selection of an Agency for providing Security Services (Security Guard and Caretaker) for BVM offices located in Patna" was published vide NIT Ref. No. BVM/2023-24/Proc/01 dated 05-10-2023.
- A total of 13 bids were received in response to the tender.
- As per schedule, **Bid Opening meeting was held at 1:00 PM on 07-11-2023** at Bihar Vikas Mission Office, Rajvanshi Nagar, Patna under chairmanship of Chief General Manager, Bihar Vikas Mission.
- First the technical bids were opened in presence of the members of Tender Evaluation Committee and representative of the bidders. Evaluation of the technical bids was carried out subsequently.
- Bids submitted by 9 bidders were found qualified in the Technical Evaluation.** The bidders qualified in the technical evaluation are - (i) Commando Industril Security Force, (ii) EX-BUREAU (iii) LORD KRISHNA SECURITY & SERVICES PVT. LTD., (iv) Maa Vandevi Security & Infrastructure Pvt. Ltd., (v) 24 Consultancy & Services, (vi) Sharan Security Services, (vii) Shiva Protection Force (P) Limited, (viii) Simanchal Detective & Security Services Pvt. Ltd. and (ix) Singh Mission Security Services.
- Bids submitted by 4 bidders were rejected in the Technical Evaluation.** The bidders disqualified in the technical evaluation are - (i) B. Amarnatha Reddy Security Agency, (ii) Intelligic Solutions, (iii) Roushan Enterprises and (iv) Sonu Kumar Enterprises.
- Proceeding of the bid opening meeting and technical evaluation was published on BVM website vide Letter No. BVM/Proc (Security Tender)-03/2023-514 dated 30-11-2023.
- Bidders disqualified in the Technical Evaluation were informed through email and an opportunity was provided an opportunity to submit their representation. In response, M/s Roushan Enterprises submitted their representation saying that they have submitted UDYAM registration for MSME and it should be considered for exemption from submission of EMD.
- Meeting for decision on representation received from bidder disqualified in Technical Evaluation and Opening of Financial Bids was scheduled at 5:00 PM on 15-12-2023 vide BVM letter no. 533 dated 14-12-2023. The schedule was communicated to qualified bidders through email. However the meeting could not be held on 15-12-2023 due to unavoidable reasons and meeting was rescheduled for 3:00 PM on 18-12-2023. Revised schedule of meeting was informed to all bidders who had come to participate in meeting on 15-12-2023 and was communicated to all bidders qualified in technical evaluation and bidder who has submitted their representation against disqualification through e-mail as well.
- As per revised schedule, meeting for decision on representation received from bidder disqualified in Technical Evaluation and Opening of Financial Bids was held at 3:00 PM on 18-12-2023 under the chairmanship of Chief General Manager, Bihar Vikas Mission.

- In the meeting, Tender Evaluation Committee discussed the representation received from M/s Roushan Enterprises. It was unanimously decided by the Tender Evaluation Committee that the request for EMD exemption on the basis of UDYAM registration for MSME cannot be considered as EMD exemption for MSME is not part of tender document.
- Financial bids submitted by bidders who were found qualified in the Technical Evaluation were then opened in presence of the members of Tender Evaluation Committee and representative of the bidders.
- Financial bids submitted by the following bidders were disqualified:
 - Ex Bureau – Error in Financial Bid in amount mentioned for ESI (error in calculation).
 - Singh Mission Security Services Pvt. Ltd. - Error in Financial Bid in amount mentioned for GST (submission at rate of 9% instead of 18%)
- Ex Bureau and Singh Mission Security Services Pvt. Ltd. submitted applications requesting consideration of their financial bid proposals. Their requests were rejected unanimously by Tender Evaluation Committee on ground of non-submission of financial bid proposal as per requisite format.
- M/s S 24 Consultancy & Services has submitted two financial bids; one was received on 27-10-2023 and other one was on 02-11-2023. However both the documents were received before last date of submission of bids which was 5:00 PM on 06-11-2023. Representative of the bidder clarified in the meeting that it has submitted the first bid before the response to pre-bid queries were published and submitted supplementary documents and financial bid in revised format after publication of response to pre-bid queries. The documents received on later date were considered in financial bid evaluation.
- Financial bids submitted by the following bidders were found in order. The rates submitted by the bidders are as follows:

- Lowest rate quoted in the financial bid was Rs 2,45,907.79 which was quoted by five bidders.
- Reference was made to guidelines notified by Finance Department, Govt. of Bihar vide letter no. एम०-4-06/2023-2988/वि० dated 23-03-2023 for availing services of outsourced manpower, wherein under para 4 (ii), it is mentioned that in the rate mentioned for service charges, digits mentioned beyond 2 digit after decimal point shall not be considered.
- Reference was made to guidelines notified by Finance Department, Govt. of Bihar vide letter no. एम०-4-06/2023-2988/वि० dated 23-03-2023 for availing services of outsourced manpower, wherein under para 4 (iii), it is mentioned that If minimum rates quoted are found to be same for more than one bidder in the financial bid, then tender shall be finalized through lottery and videography of entire process of lottery shall be done.

- As per the guidelines of Finance Department, Govt. of Bihar, It was decided to select the agency (i.e. L1 bidder) through lottery. The meeting for holding lottery to select L1 bidder was scheduled for 11:00 AM on 19-12-2023 which was published on BVM vide Important Notice No. BVM/Proc(Security Guard Tender)-03/2023-541 dated 18-12-2023 and was also communicated to all eligible bidders.
 - The meeting for selection of L1 bidder through lottery was held from 11:00 AM on 19-12-2023 in presence of representative of bidders who have quoted same lowest rates - Lord Krishna Security & Services Pvt. Ltd., Maa Van Devi Security & Infrastructure Pvt. Ltd., S24 Consultancy & Services and Sharan Security Services. Representative of Commando Industril Security Force was not present in the meeting.
 - Chits for lottery were signed by representative of the bidders present in the meeting and the chits were folded and put in lottery box their presence.
 - Videography of the entire process of lottery was done.
 - M/s Sharan Security Services was selected as L1 agency in the draw of lottery.
- The meeting concluded with a note of thanks to all participants.
