- RFP for "Selection of an agency for hiring of vehicles in Bihar Vikas Mission, Patna" was published vide NIT Ref. No.: BVM/2022-23/Proc/04 dated 20-Feb-2023.
- A total of 8 bids were received in response to the tender.
- As per schedule, **Bid Opening meeting was held at 10:30 AM on 16-03-2023** at Bihar Vikas Mission Office, Rajvanshi Nagar, Patna under chairmanship of Chief General Manager, Bihar Vikas Mission.
- Representatives of 5 agencies, namely (i) Sinha Tours and travels Pvt. Ltd., (ii) Jai Maa Durga Travels (iii) Om Surya enterprises, (iv) Rameshvaram Engitech Pvt. Ltd. and (v) Nisha Tours and Travels were present in the meeting.
- First the technical bids were opened in presence of the members of Tender Evaluation Committee and representative of the bidders. Evaluation of the technical bids was carried out subsequently.
- During bid opening, it came to the notice of Tender Evaluation Committee that one of the bidders, Jai Maa Durga Travels has been debarred by Finance Department, Bihar for non-satisfactory service and violation of agreement. In the affidavit regarding not debarred / blacklisted by any government organization, the bidder has submitted that the order to debar Jai Maa Durga Travels has been quashed by the Hon'ble Division Bench of the Patna High Court by its judgment and order dt. 31-01-2023 in C.W.J.C. No. 17856/2022. It was unanimously decided by the Tender Evaluation Committee to get opinion on this matter from Legal Officer. In light of the opinion provided by the Legal Officer, further Technical Evaluation of the bid submitted by Jai Maa Durga Travels has been carried out.
- Bids submitted by all the 8 bidders were found qualified in the Technical Evaluation. The bidders qualified in the technical evaluation are - (i) Birla Travels, Patna, (ii) Nisha Tour & Travels, Patna, (iii) Om Surya Enterprises, Patna, (iv) Jai Maa Durga Travels, Patna, (v) Rameshvaram Engitech Pvt. Ltd., Patna, (vi) Sinha Tour & Travels, Patna, (vii) Mahavir Tour & Travels, Patna and (viii) Vandana Tour & Travels, Patna.
- Summary of the Technical Evaluation and detailed Technical Evaluation Report is enclosed with the proceedings.
- Schedule for opening of Financial Bids shall be communicated over e-mail to all bidders who have qualified in Technical Evaluation.
- The meeting concluded with a note of thanks to all participants.
