- RFP for "Selection of an agency for providing Security Services (Security guards and Caretakers) for BVM offices located in Patna" was published vide NIT Ref. No.: BVM/2022-23/Proc/03 dated 20-Feb-2023.
- A total of 12 bids were received in response to the tender.
- As per schedule, **Bid Opening meeting was held at 11:30 AM on 16-03-2023** at Bihar Vikas Mission Office, Rajvanshi Nagar, Patna under chairmanship of Chief General Manager, Bihar Vikas Mission.
- Representatives of 9 agencies were present in the meeting, namely (i) Bright Bond Security Services Pvt. Ltd., (ii) Ex-Bureau (iii) Panash Infotech Pvt. Ltd., (iv) R.R. Enterprises, (v) Aparna Detective & Security Services Pvt. Ltd., (vi) Maa Vandevi Security & Infrastructure Pvt. Ltd., (vii) Duti Security Pvt. Ltd., (viii) P.S.D. Security Services Pvt. Ltd. and (ix) Commando Industril Security Force.
- First the technical bids were opened in presence of the members of Tender Evalaution Committee and representative of the bidders. Evaluation of the technical bids was carried out subsequently.
- **Bids submitted by the 7 bidders were found qualified in the Technical Evaluation.** The bidders qualified in the technical evaluation are - (i) R.R. Enterprises, Patna, (ii) Aparna Detective & Security Services Pvt. Ltd., (iii) Ex-Bureau, Patna, (iv) Maa Vandevi Security & Infrastructure Pvt. Ltd., Patna, (v) Lord Krishna Security & Services Pvt. Ltd., (vi) Commando Industril Security Force and (vii) Roushan Enterprises, Patna.
- **Bids submitted by the 5 bidders were found not qualified in the Technical Evaluation.** The bidders who did not qualify in the technical evaluation are - (i) Duti Security Pvt. Ltd., Patna, (ii) P.S.D. Security Services Pvt. Ltd., Patna, (iii) Panash Infotech Pvt. Ltd., Patna, (iv) Rottweiler Security Facility Services Pvt. Ltd., Patna and (v) Bright Bond Security Services Pvt. Ltd., Patna.

- Schedule for opening of Financial Bids shall be communicated over e-mail to all bidders who have qualified in Technical Evaluation.

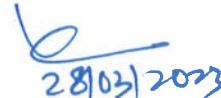
