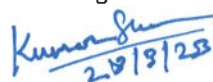

- RFP for "Selection of an agency for providing housekeeping services (cleaning of office Premises) for BVM offices located in Patna" was published vide NIT Ref. No.: BVM/2022-23/Proc/02 dated 20-Feb-2023.
- A total of 20 bids were received in response to the tender.
- As per schedule, **Bid Opening meeting was held at 12:30 PM on 16-03-2023** at Bihar Vikas Mission Office, Rajvanshi Nagar, Patna under chairmanship of Chief General Manager, Bihar Vikas Mission.
- Representatives of 12 agencies were present in the meeting, namely (i) R.R. Enterprises, (ii) Magadh Samrajya, (iii) Panash Infotech Pvt. Ltd., (iv) Duti Security Pvt. Ltd., (v) Ex-Bureau, (vi) ESEPL Group, (vii) Swacha Bharat, (viii) Bright Bond Security Services Pvt. Ltd., (ix) Maa Vandevi Security & Infrastructure Pvt. Ltd., (x) Sumitra Smarak Seva Sansthan, (xi) Commando Industril Security Force and (xii) Rameshvaram Engitech Pvt. Ltd.
- First the technical bids were opened in presence of the members of Tender Evaluation Committee and representative of the bidders. Evaluation of the technical bids was carried out subsequently.
- Bids submitted by the 10 bidders were found qualified in the Technical Evaluation.** The bidders qualified in the technical evaluation are - (i) First Idea Digital Applications (P) Ltd, (ii) R.R. Enterprises, (iii) Preeminece Security Services Pvt. Ltd, (iv) Panash Infotech Pvt. Ltd., (v) Jay services, (vi) Magadh Samrajya, (vii) Maa Vandevi Security & Infrastructure Pvt. Ltd., (viii) Lord Krishna Secuirty and Services Pvt. Ltd., (ix) Commando Industril Security Force and (x) Roushan Enterprises.
- Bids submitted by the 10 bidders were found not qualified in the Technical Evaluation.** The bidders who did not qualify in the technical evaluation are - (i) Duti Security Pvt. Ltd., Patna, (ii) ESEPL Group, (iii) Sumitra Smarak Seva Sansthan, (iv) S.S. Enterprises, (v) Swacha Bharat, (vi) Rameshvaram Engitech Pvt. Ltd, (vii) Expert Service Consultancy, (viii) Ex-Bureau, (ix) Rottweiler Security & facility Services Private Limited and (x) Bright Bond Security Services Pvt. Ltd.

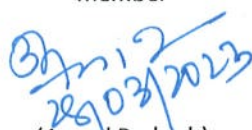

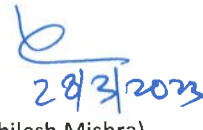
